Introduction

Why Spend Control & What Does it Take?

Organisations without effective Spend Control usually find themselves with a number of issues that are limiting their operational and financial performance.

The highest performing organisations also work to continuously **execute all of these functions at the least possible cost**.

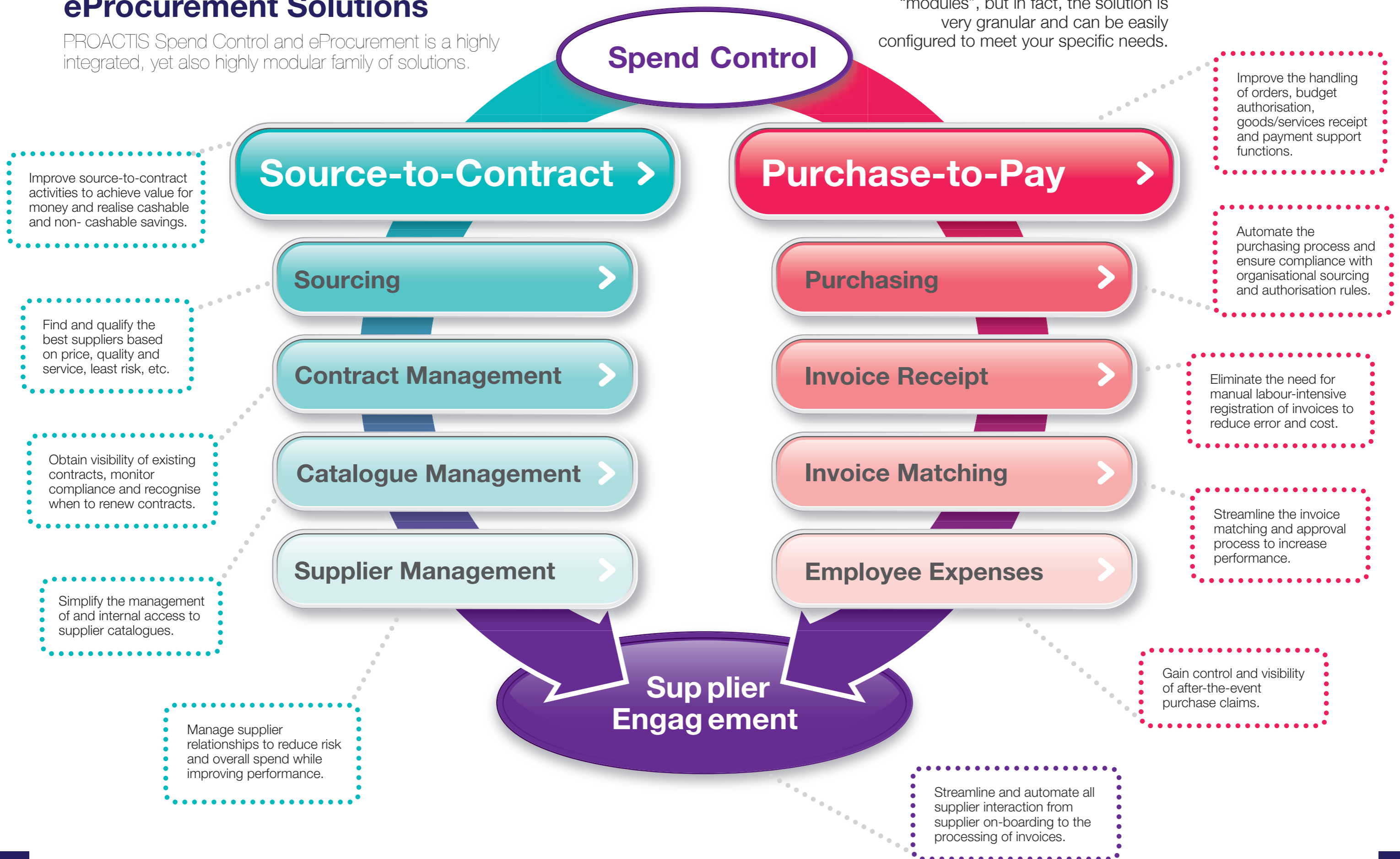
At one level, this all sounds obvious and easy. But we all know that it is a very large undertaking for any organisation, and requires constant vigilance to maintain.

Overview

PROACTIS has a comprehensive family of integrated source-to-contract solutions that help you reduce the cost of purchased goods and services while at the same time minimising risk, improving efficiencies, and increasing transparency.

PROACTIS source-to-contract solutions provide a framework of sourcing, contract, catalogue, and supplier management capabilities that enable you to leverage your organisation's full buying power, gain best value agreements, and maximise the percentage of "spend under management" across all categories of spend.

Challenge:

Whether it's for a one-time capital equipment purchase, or for ongoing supply of particular goods or services, clearly defining the need and enabling an effective competitive bidding process are critical if you are looking to obtain best value for your purchasing budget. But the process can be complex and time consuming, and it's often necessary to show that a fair and methodical approach has been taken.

Contract Management

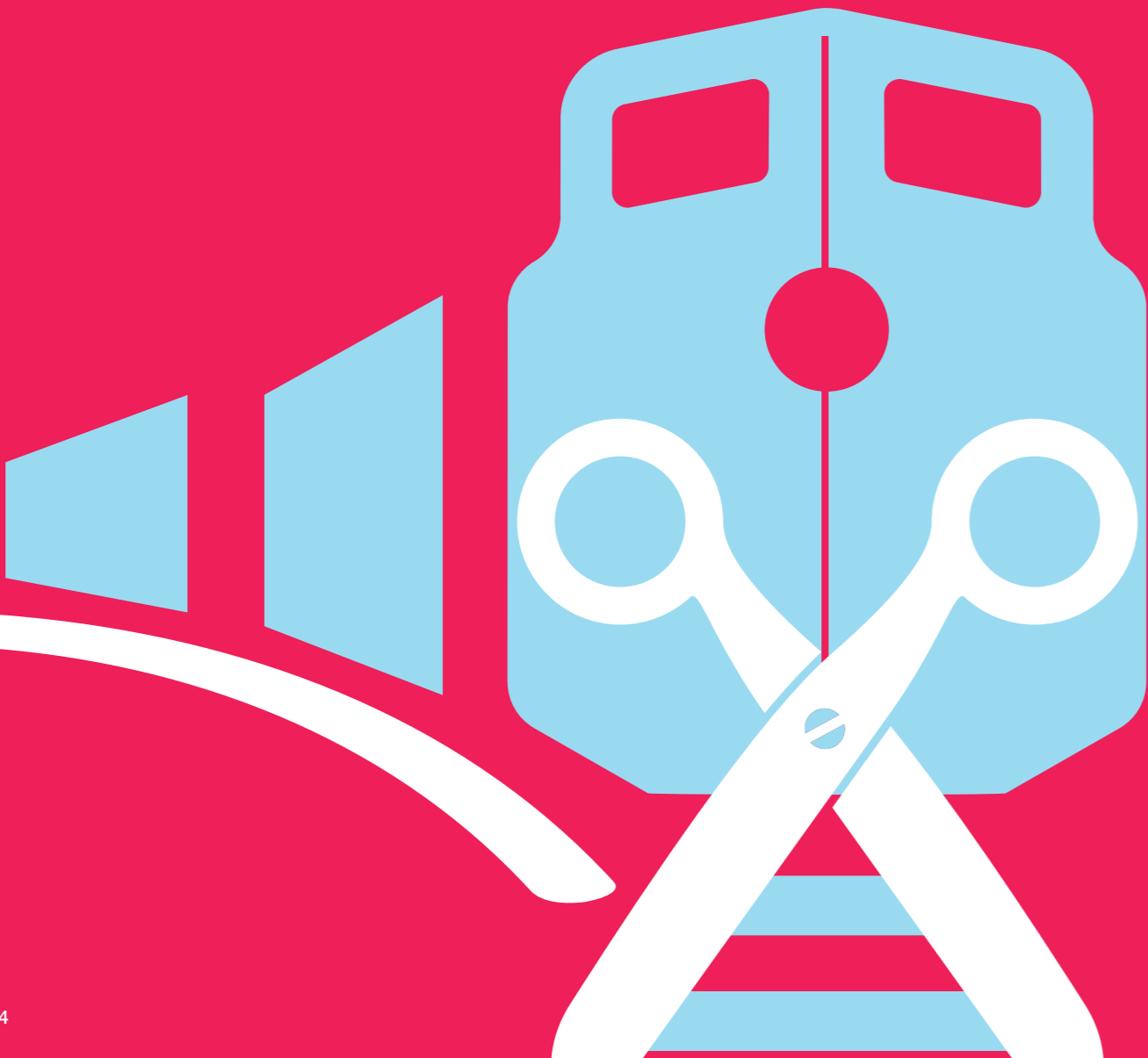

Invoice Receipt & Data Capture

Challenge:

In many organisations, invoice handling is the single most paper-intensive, "high touch", manual activity remaining today. Even organisations that have largely automated their front-office, operational and supply chain functions often still handle invoices in a very manual manner. In addition to the cost of staff and storage for paper shuffling, manual invoice capture, registration, and coding is highly prone to human error, and adds considerable latency to the payment process.

Solution:

PROACTIS invoice receipt and data capture solutions can dramatically reduce the time, cost, and potential for error involved in your organisation's handling of incoming invoices. It provides a wide range of capabilities for turning invoices into electronic records that can be processed in an automated fashion. Invoice Matching & Processing

Challenge:

No organisation can afford to pay incorrect or duplicate invoices. That's why, even though the great majority of invoices are valid, a tremendous amount of AP manpower is consumed in the process of finding and matching invoices with purchase orders, contracts, receipts, and other records; and then in researching and reconciling discrepancies with employees throughout the organisation. And after all that effort, improper payments still slip through and payments are often authorised too late to take advantage of available payment discount terms. The overall cost of this non value-added activity is typically even greater than financial managers realise.

Solution:

PROACTIS invoice matching and processing solutions automate the payment authorisation process, enabling a very high percentage of invoices to be processed "straight-through" without the need for human intervention, and while ensuring only valid invoices are paid. For exception situations, it provides automated workflow-driven communication with purchase originators to accelerate the troubleshooting process. Authorised payments are passed automatically to Accounts Payable for remittance. Reporting and analysis capabilities to give finance managers broad visibility of commitments and cash requirements.
